

SENESCHALE'S REPORT

As this year begins it is beginning to look like I will again have the shire offices filled. I do thank those people who have taken on this responsibility. I'm hoping some of our newer players will consider a deputy position so they can learn the business side of running a shire and what it takes to keep it going.

One thing I believe that keeps a shire running is expenses and income. At times I hear "Why charge for this? The shire has enough money." I'd like to run some figures past you: Tasters Site cost us \$250.00 Food came to about \$600.00 and income from Tasters was about \$650.00 Tasters cost the shire about \$200.00. Check the chronicler's report. We did nine issues and 2 different individuals did not put in a bill for printing the newsletter two months it came out. If they had we would have an additional cost of around \$50.00. Food and site for Hunter's Feast cost us \$798.00. Total Revenues was good so we gained profit over loss. The cost for Arts and Science Collegium was \$981.00. Again, our revenue was good so we gained. Three or four events, Windkeep did, broke even such as Banner Tourney and Feathers in the Wind. If we host a kingdom event here the money to cover the expenses usually needs to be in the bank before you have it.

As a final "challenge" I would like each one of you to do something new this coming year such as go to an event you never went to before, take up an office as a deputy, autocrat or co-autocrat an event, learn a new skill are a few examples. Till the next issue Your seneschale, Renate

The mundane year of 1999 has begun with the Shire of Windkeep busting at the seams. It has come to my attention that the shire is referred to as being in its third generation of membership. We have many new players who are attending practices and events with the anticipation of becoming SCA paid members during this new year. Congratulations to all who achieve that goal.

We are fortunate to have first generation members still actively participating in the Shire of Windkeep. Two of those members are Mlodn Zupan the Mercheant (Frederick Hansen) and Renate Koven (Patricia Hansen).

Renate Koven is Windkeep's current Seneschale, and has previously been Windkeep's exchequer prior to a visit to Iceland where she was exchequer. Since her return she has been chronicler. Her persona is of a 14th Century German Lady. The name Renate Koven and "Chequy Or and azure, a cooking pot sable, on a chief argent three trivets sable" are registered in May 1990 with the society. She has been presented with her Trefoil and Stag's Heart, since receiving her Award of Arms on January 10, 1987.

Mlodn Zupan the Mercheant attends events armed with many swords and chain mail. He is always armed with the knowledge of a herald, carrying the books of research required. "Per saltire gules and sable, in fess two saltorels couped argent" is his registered device. Mlodn received his Award of Arms January 10, 1987 and a Stags Heart October 10, 1998. Recently Mlodn stepped down as Windkeep's herald, but he is always willing to help do period research. He has been Arts and Science Officer and Chronicler of Windkeep prior to working in Iceland where he was herald. As a 12th Century Serb merchant, his experience with money will assist him in his current shire office of exchequer.

Mlodn and Renate joined the SCA in 1985 as two of the original members of Windkeep. When they moved to Iceland in 1989 they were instrumental in establishing a new SCA group in the Kingdom of Drachenwald. Since returning to the Kingdom of the Outlands in 1993, they have both supported the Shire of Windkeep in anyway possible.

Mlodn and Renate are always willing to help in most activities. They have an extensive research library. As merchants they sell most any item a Lord or Lady would need to participate in the "Dream of the Middle Ages."

COURT BARON AND BARONESS

Greetings from your Kingdom Seneschal,

First, I would like to congratulate Their Excellencies Master Rhys and Mistress Aldyth, the newest Court Baron and Baroness of the Outlands. Let me take this opportunity to review some of the customs surrounding a Court Barony and how it differs from a Territorial Barony.

There are, of course, two types of Barons and Baronesses. The first type, with which most of us are more familiar, is the Territorial (or Landed) Baron and Baroness. These are the Ruling Nobles of a Barony who hold lands for the Crown. Our Kingdom has five Baronies and each has a Baron and Baroness as its Ruling Noble who represents the Crown in Their absence. The Crown allows the Baron and Baroness to present awards to the Barony's populace with Their approval. The duties and privileges of Territorial Barons and Baronesses are enumerated in Outlands Kingdom Law. These Barons and Baronesses are chosen by the Crown after a polling of the populace is held for the Crown hear the desires of the group before making Their decision. In the Outlands, Territorial Barons and Baronesses wear a Coronet with six spheres.

The second type of Baron and Baroness is the Baron/Baroness of the Court, often referred to as a Court Baron or Baroness. These gentles have been recognized by the Crown for any number of reasons. Each Crown has Its own preference in giving this award. Many times is it given for long-time service to the Outlands; it may be given for special service to a Crown; it may be given in recognition of a gentles noble bearing and demeanor. The point I am making is that the King and Queen of the Kingdom may give a Court Barony at Their discretion. When Ruling Barons and Baronesses step down from the Baronial throne, after having served their Kingdom and Barony, they are usually given a Court Barony in recognition of that service.

A Court Barony may or may not carry with it a Grant of Arms. You will know this by listening to the reading of the scroll, by reading the scroll yourself, or by asking. If it carries a Grant, the Court Barony has the same precedence as a simple Grant falling just below the Grant Orders (Stag, Iron Hart, Flower, Sharparrow, and White Scarf); if it does not carry a Grant, it carries the same precedence as the Kingdom level awards (Argent Hart, Stags Hart, Stags Blood, Golden Pheon, and Silver Tyne).

In the Outlands, those gentles who are awarded a Court Barony wear a Coronet with six spheres as a symbol of the title. Customs, of course vary from Kingdom to Kingdom. Court Barons and Baronesses are referred to as His or Her Excellency. They are given respect by using "Your Excellency" when speaking with them and by offering a curtsy or bow when approaching them. Often gentles are unsure whether to call a Court Baron/Baroness, Baron such and what or using a previously awarded form, such as Master or Mistress. Each Court Baron or Baroness will generally have a preference as to which title to use, but often it takes a while to determine that preference. Some have personas which are in keeping with the Baron or Baroness title and they prefer that title; others prefer to use their highest award, such as Master or Mistress; some simply don't care. You will be safe in using their highest title, which gives great respect to them. When a Court Baron or Baroness makes a decision as to title preference, very often he or she will inform the gentles with whom they come in contact. It is not improper to ask for a preference.

In summary, Court Barons and Baronesses do not represent the Crown but they are expected to carry themselves with noble bearing. They hold no lands for the Crown and give out no awards. They will most likely continue to do the things they have always done, such as autocratting events, cooking feasts, etc. Although we show respect to all gentles, we show an every extra measure of respect to these nobles, and they are expected to act accordingly.

The Shire of Caer Galen with the cooperation of the Barony of Caerthe invites Artisans one and all, in the anticipation of Spring, to display the flowers of their artistic endeavors. The main purpose of this event is to encourage Artisans of all levels to enter A&S competitions and give them the skills to do this in an effective manner. However, there is something for every artisan, be they novice or Laurel. There are three main parts to this event; a Queen's Prize type display, a Reverse Laurel's Prize display and classes pertaining to the entering of A&S competitions.

The Artisan's display will have two divisions: Novice and Regular. There will be 2 Champions chosen, one from each division, by public acclamation. Artisans may enter both Divisions up to a total of 6 entries. Kingdom rules apply with these exceptions: no entry limit in a category and you will not be required to evaluate if you are entering in the Novice division. Laurels are invited to bring their favorite work with documentation for display.

We would like to have pre-registration of entries if possible, in order to schedule evaluators in advance. Also, each Artisan's work will be displayed as a whole and we will need to know how much space to allow and to schedule evaluators with knowledge in the proper areas. However, if you do not preregister you may enter but will be limited to 3 entries.

Bring your best Italian garb to wear for the evening's festivities, which will include both music and a sumptuous Italian Feast. Opening court will be at Their Majesties' discretion. DA'UD BOB'S MOVIE REVIEW

MUPPET TREASURE ISLAND * *



It's not every day that I, as a regular movie reviewer, get a chance to write about a "scurvy crew" like this one. I mean, really! A frog, a pig, a rat, and a, ah, um, a "whatever". But we'd recently acquired the videotape at the local Greater World of VideosTM store, and Anna Sue said that, by golly, she didn't care if it was out of period, so was Cutthroat Island, and I'd reviewed that. Unable to come up with a good argument to refute that logic (mind you, it's impossible to argue with Anna Sue's logic at any time, no matter what the topic is, so don't even try), and thinking it couldn't be worse than, say, Deathstalker or Robin Hood Men in Tights, this month Da'ud Bob reviews Muppet Treasure Island.

Starring, of course, all of the muppets (they even worked in the Swedish Chef!), but most especially Kermit the Frog as Captain Smollet, Miss Piggy as Benjamina Gunri, Rizzo the Rat as Rizzo the Rat, and the Great Gonzo as a, a, "whatever", the movie also starred Tim Curry as Long John Silver, Billy Connolly as Billy Bones, and introduced Kevin Bishop as our erstwhile hero, young Jim Hawkins.

I hope that none of you are going to tell me that you don't know what the plot is. It's the same as every other movie entitled Treasure Island, and for that matter, is the same as the book of the same name by Robert Louis Stevenson. So you are left without excuse for being ignorant of this tale of treasure hunting, pirates, and adventure on the high seas.

There were a goodly number of good points. Some of the costuming. The music, especially the songs. (The song during the opening credits is especially good!) Everybody looked like they had a lot of fun making this movie. The shipboard roll call. A real elephant.

Bad points: An elephant? In the Caribbean?? The talking tomato.

Zero breasts. No blood. Seven dead bodies (without counting "Dead Tom" twice. "But Dead Tom's always been dead. That's why he's called Dead Tom."). Waves roll. Ship rolls. Lapels roll. Gunpowder fu. Flintlock pistol fu. Gratuitous Casablanca reference. Gratuitous Star Trek references. Gratuitous talk of the "Zanzibarbarians". And "their exploding wigs of death."

Academy Award nominations to Tim Curry as Long John Silver for so obviously enjoying his role and for "We're a festival of conviviality"; to Sam Eagle as Mr. Errol, for "Any man caught dawdling will be shot on sight." "Mr. Errol, I didn't say that." "Oh, well, I was just paraphrasing."; to Miss Piggy as Benjamina Gunn for "I took up with this Bernie Flynn. He was totally co-dependent"; and to Kermit the Frog as Captain Smollett for "Don't cry for me, Benjainina". A mere 72 on the Vomit Meter. Three Stars. Da'ud Bob says "Check it out!".

AGAINST ALL FLAGS & & O

Aaaaarrrrgh, mateys! Heave to and prepare to be boarded! Now, don't get me wrong. I like Geena Davis in Cutthroat Island. She's smart, she's clever, she's sexy, she's cunning, she can fight with the best of them and still

come out on top. But long before Geena Davis was even a glint in her father's eye, there was another who was smart, who was clever, who was sexy, who was cunning, and who could fight with the best of them and still come out on top. And she did fight with the best of them, too: that swashbuckler par excellence, Errol Flynn in his mature prime. If anyone can be said to have pioneered the way for strong women characters in historical movies in roles usually reserved for men, it had to be this particular lady. And lady she was, too, even if she did have a habit of pulling pistols on would-be suitors. (On the big screen, of course, not in real life. At least, I don't think so.) And so it is that this month, Da'ud Bob introduces you to the pleasure, nay, the joy, of watching the uncontested Queen of the Swashbucklers, Maureen O'Hara, in one of her best films (after The Quiet Man, of course, but that's a whole different genre of movie), Against All Flags.

Starring Errol Flynn as Lieutenant Brian Hawke of His Brittanic Majesty's Navy, Anthony Quinn as the pirate Captain Brasiliano, Maureen O'Hara as pirate captain Prudence "Spitfire" Stevens, and Mildred Natwick as Mrs. McGregor, the basic plot of this one can be summed up as: British naval officer goes under cover on pirate island hideout in order to neutralize their defenses. Oh, yeah, he falls in love, too. Naturally, there's a bit more to the movie than just that, but this is a pretty good summarization of all the essential points.

Good points: Maureen O'Hara's boots. Maureen O'Hara's vest. Maureen O'Hara's dresses. Let's face it - Maureen O'Hara. And Mrs. McGregor trying to hide a loaded pistol in her petticoats, even though it's fairly obvious she doesn't know how to use one without endangering herself.

Bad points: Gauze face veils on the "Moorish" women. The sailors and shipboard soldiers of the "Grand Mogul" were wearing Turkish uniforms. (The Mughals ruled in India.) Why they didn't just spike the cannon I'll never know. But, no, they had to make a lot more noise fixing them to blow up when fired, instead of simply making it impossible to fire them. And why did none of the pirate ships spot the British man o' war if it was close enough to see, and respond to, a rocket fired from the island?

Zero breasts. No blood. 21 dead bodies. Pirates roll. Hasan the Eunuch rolls. Waves roll. Cannon rolls. Boarding pike fu. Cannon fu. Cutlass fu. Knife fu. Head fu. Gratuitous flogging. Gratuitous slave auction. Gratuitous crabs. Academy Award nomination to Maureen O'Hara as "Spitfire" Stevens for "Well, I'm not weaker. I go after what I want just like they do" and for "My father taught me how to defend myself against rough men. But he told me he could only warn me against gentlemen." An 87 on the Vomit Meter. 2 1/2 Stars. Da'ud Bob says, "'Again?' 'Again!' Check it out!"
